## 4. UPDATE ON CSA 16 ACTIVITIES

Jim Chayka provided updates on the Sir Francis Boulevard frontage improvement project. Scott Sherman provided updates on annual pruning and landscaping. These included Via La Cumbre, Sir Francis Drake Blvd frontage, and Manor road entrance fencing. Jim suggested discussion around looking to share funding for firesafe pruning on Bretano Way with MWPA, estimated at \$48,000.

## 5. FISCAL YEAR 2021-2022 BUDGET AND FISCAL YEAR 2022-2023 BUDGET REVIEWS

Jim Chayka presented updates on the FY 23 Budget. Total expenses for FY23 was \$ 298,946 as of the end of the fiscal year, including water bills, tree services, and leak detection. Total revenue was higher than total expenditures. Professional services expenditures were lower than estimates because there was planned planning along SFD frontage that was moved into FY 24. Jim then reviewed the estimates for FY 24. \$110,000 is allocated for Sir Francis Drake, and expenditures are estimated to be larger than revenue by nearly \$200,000. However, projected fund balance is still \$357,000 dollars at the end of FY 24.

Commissioner Comments: Wittenkeller appreciates the involvement of Sarah Richards in the community, especially in regards to Sir Francis Drake planning.
