**4. IPM COORDINATOR'S 2020 THIRD QUARTER REPORT**

Kat Knecht presented the 2020 3<sup>rd</sup> Quarter Report.

Total staff hours for 3<sup>rd</sup> Quarter were 5442, Volunteer Hours 3588, Contract Labor Hours 3114 for a total of 12144.

Kat went over the Marin County Pesticide Exemption Process and is as follows:

- Request to use pesticides comes to the IPM desk from staff or contractors.
- IPM staff will ask "is treatment needed at all and are there nonchemical options",
- if yes, nonchemical method or less toxic product will be used.
- If non chemical options are not effective, Environmental Health Dept review treatment proposal, public posting will occur and then post-treatment monitoring will begin.
